4. Print

- Print // image : grid of 28
On request: opening note + Story „organic waste bag“
- Colours : max. 3 colours
Environmentally friendly water-based paints
- Print pages : both sides possible
Cut out longitudinal adhesive in the middle of the back
Siede edges not printable

5. Sealing

- Type of sealing : Longitudinal and bottom gluing (block bottom)

6. Packaging

- Standard : 100 pieces/paperboard
5.000 pieces/pallett

7. Processing

After removing the protection paper press firmly over the entire bag surface. The bags should be fixed at temperatures $>+ 10^{\circ}\text{C}$.

8. Durability and Stocking

When kept in a dark and dry place at room temperature (between $+10^{\circ}\text{C}$ and $+30^{\circ}\text{C}$), the bags can last for 2 years. The products must be protected from direct sunlight.

The recycled paper used meets the criteria of the Blue Angel according to RAL-UZ 14, which means that the paper is free of critical or technically avoidable chemicals (e.g. chlorine bleach, optical brighteners).

Recycled paper is obtained from paper waste collected from households or commercial enterprises. Paper recycling removes most of the questionable substances derived from printing inks from newspapers and packaging, but the paper cannot be completely freed from mineral oil. For office use, however, recycled paper does not pose a health hazard, as the mineral oil concentration is not harmful to health. The production of the various grades of recovered paper is based on the "List of European Standard Grades and their Qualities" drawn up by the paper industry and suppliers of recovered paper. In European Standard EN 643:2014-05, this list describes 95 recovered paper grades in terms of composition and quality. The quality of recycled paper is - with very, very few exceptions - absolutely equal to the quality of virgin fibre paper.
