Film	:	Polyethylene (LDPE), transparent
Film thickness	:	50 μ m - 140 μ m (+ 10 %)
Adhesive	:	hotmelt with high adhesive power, solvent-free
Colours	:	solvent based pigment colours During the production process the solvent vapours are extracted and recycled thermally.

3. Closure system

Security Closure	:	DEBATAPE, DEBATAPE <i>plus</i> , DEBATAPE <i>high plus</i>
Security features	:	manipulation indication at any attempt to open
Masking Tape	:	Release paper (one-side siliconised)

Flex print : on customers preference, up to 8 colours

5. Coding

Numbering : 6 – 16 digits

Barcode : 39, 2/5, 128 or EAN

6. Sealing

Type of sealing : double shrink seal

7. Packaging

Standard : see the stock programme on product data sheet

8. Processing

DEBASAFE security bags should be fixed at temperature > + 10°C. After removing the protection paper, seal the opening well by pressing firmly over the entire closure surface.

9. Stocking

When kept in a dark and dry place at room temperature (between +10° C and +30° C), the pouches can be stored for at least 2 years.
